We wish to share that our Senoko Plant enjoys more than 14% savings, from a daily Diesel consumption of 8,000 liter reduced to 7,000 liter as a result of replacing all conventional Steam Traps to SteamPro CRDs.

Furthermore, our Ironer process temperature increases from a normal 180 degree Celsius to 190 degree. This 10 degree increase in process temperature created more productive and happier staff. Our management is now figuring out ways to tap on this vast increase in process temperature as a outcome of CRD to so as to further increase our productivity now that we have the option to run our press machine at higher speed.

We are looking forward to another 15% savings to make it a total 30% saving after Condensate Recovery Unit, (CRU) is commissioned for Senoko Plant.

As for Tuas Plant, we are impressed to witness how the flash steam at feed water tank disappeared and flash steam energy is recovered to boiler soon after CRU is turned on. Together with full conversion to CRDs , we experience an estimate overall 30% Steam Energy Cost savings due to SteamPro System is in place.


